Frequently Asked Questions

What is the College of Charleston Fund?

The College of Charleston Fund is the primary channel for donors to support the core values of the College and its greatest assets. It represents the area of greatest need on campus. With a gift to the College of Charleston Fund, you declare your support for what makes this institution great. In general, the CofC Fund supports: student scholarship, faculty & staff retention, and alumni engagement.

How can I make my gift?

Automatic Payroll Deduction: Payroll deduction is a convenient way to make your gift. This option allows you to deduct a small amount from each pay period that makes a big impact over time. Simply complete the online form to make a new payroll gift or adjust your current payroll gift.

The College of Charleston Faculty & Staff Giving Drive focuses on participation and employees joining together to make an impact. No matter the size, every gift counts towards our goal. Consider a one-time gift, payroll deduction or a planned gift.

I donated during the Trident United Way Campaign. Is this counted in the Faculty and Staff Giving Drive?

No, the Trident United Way campaign supports nonprofits in the Lowcountry community. Gifts made during the Trident United Way campaign are not included in the Faculty and Staff Giving Drive totals.

Do you accept matching gifts?
